I have been directed to inform you that the Inspection committee which visited your Institute on 17.06.2023 to verify the compliance of previous conditions of affiliation to consider the matter for grant of Ex-post facto extension/continuation in provisional affiliation for the session 2021-22 & 2022-23 and grant of extension/continuation in provisional affiliation for the session 2023-24 for B.Tech., M.Tech., BBA and BCA Programs has submitted its report. The report of the Inspection committee has been considered by the Vice-Chancellor. On the basis of the recommendations made by the Inspection committee, the Vice-Chancellor has been pleased to grant Ex-post facto extension/continuation in provisional affiliation for the session 2021-22 & 2022-23 and extension/continuation in provisional affiliation for the session 2023-24 for the following programs alongwith sanctioned intake as mentioned against each:-

Inspection Report of Delhi Global Institute of Technology, VPO-Barhana, Distt. Jhajjar for checking of compliance report - matter regarding grant of Ex-post facto extension/continuation in provisional affiliation for the session 2021-22, & 2022-23 and grant of extension/continuation in provisional affiliation for the session 2023-24 in M.Tech, B.Tech, BBA and BCA programme.

The inspection committee constituted by the Vice Chancellor vide letter No. CB-II/199/2023/9518 dated 07.06.2023 comprising of Prof. Satyawan Baroda, Dr. Rahul Rishi, Dr. Vikash Nandal, Dr. Vineet Kumar, Dr. Pradeep Kumar of UIET, Dr. Sajjan, of Deptt. of Physics, and and Dr. Naveen of Deptt. of Chemistry, MDU, Rohtak visited the above mentioned Institute on 17.06.2023 to check the previous compliance report and verify the available requisite infrastructural facilities and other support system in order to consider the matter for granting extension/continuation in provisional affiliation for existing courses/intakes for the session 2021-22 & 2022-23 Ex-post facto and session 2023-24 extension/continuation in provisional affiliation.

The committee physically verified infrastructural facilities, statutory requirements and other support system of the institute required by the University for extension/continuation of the programs M.Tech, (Mechanical Engg) 18, M.Tech (Electronic & Communication) 18, M.Tech (Computer Science and Engineering) 18, B.Tech, (Computer Science and Engineering) 60, B.Tech. (Civil Engineering) 30, B. Tech. (Mechanical Engineering) 30, B. Tech. (Electric & Communication) 30, BBA 180, and BCA 180 programme.

Observations:

1. **Compliance of previous report:** The institute was visited lastly by the inspection committee on 18.02.2021 and pointed out various observations were checked by the present committee. The institute has partially complied the deficiencies pointed out by the earlier committee and the major condition of appointing staff through duly constituted selection committee as per AICTE/MDU norms as well as the appointment of senior faculty in all the branches as per AICTE prescribed cadre ratio still needs to be complied with.
2. **AICTE Approval:** The Institute has already got approval from AICTE for all the above courses for all the sessions 2021-22, 2022-23 and 2023-24. (Copy enclosed).
3. **Governing Body:** The governing body is yet to be constituted by the institute according to MDU norms.
4. **NAAC/NBA:** The institute is not yet initiated for the accreditation of NAAC/NBA.

5. **Building:** The institute has campus of 10.5 acres of land and having two stories building with adequate built up area to meet out the requirements for the said programmes. The building has Principal office, Chairman Office, Admin offices, Laboratories, Engineering and computer science labs, Workshops, 32 Classrooms, 12 tutorial rooms, HoDs and Faculty rooms, Library and common rooms for boys and girls.
6. **Enrolled Strength:** The institute has enrolled students in the session 2021-22 (341) and 2022-23 (296) students in all courses against sanctioned intake of 555.
7. **Lecture theaters:** The institute has thirty two partially furnished lecture theaters. The relevant infrastructure facilities were lacking in the institute and the same were communicated to the authorities. There is a semi furnished seminar hall for the students of in the institute.
8. **Infrastructure Facilities:** During the physical verification of infrastructure facilities for placement cell, common rooms for boys and girls, teacher's cabin, first aid facilities are still to be updated in terms of infrastructure in the institute.
9. **Computer Lab:** The institute has four separate computer labs and total computers in all labs were 250. Out of these computers only 190 computers were functional with old windows (pirated) and rest of the systems were very old and out of work. There were five printers in the computer labs.
10. **Technical Labs:** The institute has sufficient number of technical labs with required equipments for the practical purposes. All labs are functional but their proper maintainence is lacking on the part of human resources.
11. **Library:** The institute has a big space library having 14315 books with 211 titles. In the session 2022-23 the total books were 12353. The institute has also subscribed 75 international and 99 national research journals. There were only four news papers (two Hindi & two English). The infrastructure such as chairs and study tables, new arrivals corner, issue return counter etc were not sufficient to consider for such a library. Library has no photocopier and printer to fulfill the student's requirements. Library has not been given proper attention to provide the essential facilities such as new books of standard publications, reading space, new arrivals corner, required infrastructure, and adequate property counter, photocopier, PC's with internet etc.


12. **Administrative Block:** The institute has an adequate administrative block for teaching and non-teaching activities, but it is lacking in its proper maintenance and infrastructure. Space for the examination centre, faculty cabins, student's common rooms, placement cell etc. lacking proper infrastructure.
13. **Faculty:** The institute has a regular unapproved Principal to lead the institute but the appointed senior faculty such as one Professor and three Associate Professors are not still got approved by the university. At present only 10 teachers in B.Tech and M.Tech 4 teachers in BCA and 8 teachers in BBA are approved by the university out of total appointed 74 Assistant Professors. The institute only fulfills the criteria of Assistant Professor as per ratio required. This lap was also pointed out by the earlier committee in its report but the institute has not taken any initiative in this regard so far. It is pertinent to mention that the institute has not taken any serious initiative to appoint senior teaching faculty such as Professor and Associate Professor as per university rules.
14. **Non Teaching Staff:** The Institute has appointed Administrative officer, Librarian,,TPO, two computer operators, two technical assistants, two data entry operators, six lab attendants, two library attendants, tow accountants, four office clerks, one supervisor, two instructors and two lab technicians but no one is approved by the university. In addition to that the institute has sixteen unapproved supportive staff.

Recommendations:

- (i) In view of the above observations the committee recommends that the Ex-post facto extension/continuation in provisional affiliation for the session 2021-22, & 2022-23 for the programs M.Tech, B.Tech, BBA and BCA be granted keeping in mind the future of the students.
- (ii) The institute may be granted provisional affiliation/continuation for the session 2023-24 for the above mentioned programs on fulfillment/improvement of the deficiencies before starting the session so that the students may not suffer.
